The Government of Albania (GoA) has received a loan in the amount of 65.9 Million Euro's financing from the World Bank toward the cost of the Results Based Road Maintenance and Safety Project (RRMSP) and intends to apply part of the proceeds for individual consulting services.

The Government of Albania is intending to borrow to finance the Albanian Road Asset Management Systems Project. The Project will be implemented by the Ministry of Infrastructure through Albanian Road Authority (ARA). The objectives of the project will be the establishment of an objective method of maintaining Albania's National Road Network through the establishment of a Road Asset Management System (RAMS) for better Resilience to Climate Change and Geological hazards.

Interested Candidates should provide information demonstrating that they have the required qualifications, they are familiar with the requirements of RAMS in projects funded by the World Bank and demonstrate previous experience as a RAMS Coordinator.

## **Qualifications and Skills**

- Bachelor's degree in finance/economics/business or Civil Engineer with roads equivalent experience; 3 years since finishing Bachelor's degree / 2 years since Master's degree from accredited university;
- At least 2 years experience in pavements or finance/economics/business management. Some knowledge in asset management would be nice to have;
- Capacity to communicate orally and in writing in both Albanian and English languages;

- Excellent interpersonal and communications skills, demonstrated ability to work in a team, teamwork skills;
- Have no restriction for travel,

## **Duration**

Duration of service of the RAMS Coordinator should be within a period as fourteen (14) months but must not run beyond December 31, 2022
